## Remote Registration Terms and Conditions

- 1. Terms and Conditions hereinbelow regulate remote registration of an individual in a Bank's system for purposes of opening an account with VTB Bank (Georgia) JSC;
- **2. VTB Bank (Georgia) JSC** RID 202906427, hereinafter referred to as "Bank", with registered office: 14 G. Chanturia str., 0108, Tbilisi, Georgia; contact e-maiil: <a href="mailto:info@vtb.ge">info@vtb.ge</a>; official web-site: vtb.ge where you can find addresses to Bank branches/service centers, as well as about services offered. Banking license ID: 226a, issued on 25.12.2016. The regulatory body is National Bank of Georgia with official web-site nbg.gov.ge;
- 3. In accordance with respective legislative procedures and rights thereunder the Bank shall collect personal data and a consent to opening a banking account from an individual, wishing to open an account with the Bank, via respective software;
- 4. By disclosing his/her personal data and pressing respective "accept" button in a software, the individual confirms that:
  - 4.1. He/she wishes to open current [card] account with VTB Bank (Georgia) JSC and receive respective banking card;
  - 4.2. Information disclosed/ provided is truthful and accurate;
  - 4.3. Bank shall be entitled to process information disclosed [name, surname, phone number, address] for purposes of rendering banking services and communication.
- 5. The individual is aware that the company rendering technical support to the Bank (hereinafter "Tech Support Company") shall gain access to following types of information:
  - 5.1. His/her personal data engraved on ID document;
  - 5.2. His/her will expressed in regard with opening an account with VTB Bank (Georgia) JSC;
  - 5.3. The fact of him/ her owning an account with VTB Bank (Georgia) JSC.
- 6. The Bank states and warrants that:
  - 6.1. The purpose of disclosing information listed above to the Tech Support Company is rendering banking services to the individual;
  - 6.2. Tech Support Company will not disclose this information to third parties and/or use it for any purposes other than warranted;
  - 6.3. The information will be immediately deleted by the Tech Support Company as soon as there is no need for their technical support.
- 7. If an individual wishes to receive a card within administrative boundaries of Tbilisi, the Bank shall deliver it to the address disclosed. As for delivery of cards in the regions the individual shall collect it at the Bank's sales point requested in application;
- 8. The individual is aware that the account opened with the Bank shall remain passive, i.e. he/she will be unable to carry out any banking transactions, before respective banking card is not delivered and documents provided by the authorized Bank representative are not signed;
- 9. If the individual fails to collect a banking card and/ or sign documents provided by the authorized Bank representative within 1 (one) month after the account opening application is submitted the account shall be closed.

10. The individual confirms that signature sample available on ID document (ID card or passport) shall be deemed by the Bank as a sample of a signature that the individual will use when conducting business relations with the Bank.
